Well needed change in design law?




In November 2022, the European Commission has proposed a revise of the Community Design Regulation and the Design Directive. The objectives thereof were to open up the spare parts aftermarket for competition; to improve the accessibility, efficiency and affordability of registered Community design protection; and to increase complementarity and interoperability between the Community and national design systems, in particular by aligning procedural rules.

This Round Table will cover many aspects of the upcoming reform of the Community Design Regulation and Directive. The Round Table will host speakers from both the governmental side (EUIPO and BOIP) and from the practitioner's side.

→ Heading towards the Round Table

The Royal IGC is located in the city centre of Amsterdam and is easy to reach in various ways. **Schiphol airport** is nearby and near the Club several parking garages are located.
